

Black & Decker Centennial Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Void where prohibited. Sweepstakes begins on or about February 10, 2010 and ends on December, 31, 2010 (“Sweepstakes Period”). This Black & Decker Centennial Sweepstakes (the “Sweepstakes”) is intended for participation in the continental United States, Alaska, Hawaii or the District of Columbia and Canada only and, to the extent permitted, shall be construed and evaluated only according to United States law. **Do not proceed in the Sweepstakes website if you are not located in the continental United States, Alaska, Hawaii, the District of Columbia or Canada at the time of entry.**

Who may enter: Sweepstakes open to legal residents of the 50 United States or the District of Columbia who are 18 years of age or older, as of January 1, 2010 and legal residents of Canada who have reached the age of majority in their province of residence as at January 1, 2010. Employees, officers, and directors of Black & Decker (U.S.) Inc.
